MEMBERSHIP / INSTRUCTION FEES:

The WCM Membership fee is \$395 and includes no instruction. For new sailors, the Complete Sailing Course is \$1250 (For a limited time only) and **includes membership, instruction and four levels of ASA certifications**. Fees for membership and sailing lessons must be paid in full on confirmation of your application. These fees are not refundable unless your application is denied.

Dues, Payments, & Late Charges:

~~Member agrees to pay \$90 dues per quarter (every three months). Applicant authorizes West Coast Multihulls to charge dues to credit card listed below. Sailing dues are not refundable and cannot be transferred.~~

Security Deposit:

A \$100 refundable security deposit is required before any charter reservation can be confirmed. The security deposit, less any amount due to WCM, will be refunded within 30 days after termination of membership.

Canceling Membership:

To avoid any misunderstanding, written notice, signed by the member, is required to cancel that membership.

Membership Termination:

WCM reserves the right to cancel any membership at any time for non-payment of dues or other fees, or for conduct that is, in its opinion, detrimental to the orderly conduct of the club or the happiness and well-being of its members and owners.

Insurance:

Insurance: All boats carry deductible hull insurance. In the event of damage or loss of equipment, the charterer will be liable for the full deductible amount of \$500 or 1% of the value of the boat; whichever is greater. If repairs/replacements do not exceed the deductible amount, a refund will be made.

Responsibility:

The applicant hereby absolves WCM and its owners and employees of any responsibility or the obligation in the event of an accident regardless of the consequences. WCM and its owners and employees shall not be liable for any personal injuries or property damage sustained by the applicant or his/her guests on their property, or for the condition or use of the boat or its equipment. The applicant agrees to hold WCM free and harmless from any loss or injury sustained by the applicant while on board the boat or engaged in club activities.
